

## **Southern Outdoor Sports Shipping Policy**

If you are not happy with your purchase, you can return most items for a refund within **15 days** of purchase as long as it is still in **"sellable condition."** Merchandise must be in original purchase condition to be eligible for refund or exchange. This means the item should

- be unworn (aside from trying it on)
- tagged
- unwashed
- devoid of any stains, scuffs, tears, or mysterious smells
- needs to be in its original packaging.

Refunds are only given in the original form of payment. Shipping charges are not refundable for any reason on returns.

You may return your online purchase in-store, accompanied by copy of the sales receipt.

### **FINAL SALE ITEMS**

- All headwear and headgear
- Swimwear
- Undergarments
- Socks
- Facemasks
- Gift Cards (They will also not be replaced if lost, stolen, or used without authorization.)

**Sunglass Policy** - There is a **15-day** return policy on all sunglass purchases made online. Returned frames must be in sellable condition (sellable condition is the exact condition you received the item).

**Optics Policy**-No Return on optics. If broken in shipping contact Southern Outdoor Sports the day you receive the item. Also file a claim with the shipping company.

Oversized or bulky items may result in additional shipping and handling costs.

### **Ammo Shipping Policy**

**You must be 21 years old to purchase from this site.**

By purchasing ammunition through this site, you agree to take full responsibility for your order once it has been delivered. This includes carrier hand-to-hand and drop-off deliveries. Please monitor the tracking status for your package. If your ship-to address is one where any packages

left by the carrier will be visible to the public, we recommend making arrangements to have someone retrieve the package upon delivery to avoid theft.

All orders must be sent to a physical address. In accordance with Federal Law, ammunition cannot be sent to a P.O. Box. All ammunition is shipped via ground service to contiguous 48 states only. No International shipping. Check your local laws for any other regulations before ordering.

There are no returns on the purchases of ammunition.

**Firearms Shipping Policy**

By federal law, we are unable to ship any firearm directly to you. However, we can ship to any FFL (federal firearms license) dealer of your choice. Additional fees thru them may apply.

Handgun MUST go 2<sup>nd</sup> day air. Long guns will go ground unless customer ask for next day or 2<sup>nd</sup> day delivery. Additional fees will be added for upgraded delivery.
